Jonathan led a team of counsel representing United Utilities in the leading case on the entitlement of owners of watercourses to maintain claims in nuisance against sewerage undertakers for discharges of polluting water into watercourses. The case also confirmed *Marcic v Thames Water plc* [2003] UKHL 66 remained good law and that the only remedy for sewer flooding due to the inadequacy of sewerage infrastructure was through the statutory scheme.
