

# Thomas Rothwell Called 2017

## **Practice Summary**

Thomas accepts instructions in all areas of landlord and tenant law, whether residential, commercial or agricultural, as well as the law of real property more generally. He has established a busy court and advisory practice, featuring regular appearances in the County Court, the Property Chamber of the First-tier Tribunal and the High Court.

Rated since 2023 in the Chambers and Partners Guide to the UK Bar, Thomas has been described as "a future star of the Bar" with a "phenomenal work rate" and "an exceptional eye for detail". His client care has been labelled "second to none".

Thomas enjoys both the cut-and-thrust of the court room as well as puzzling out problems in chambers. His most recent cases have covered the following areas:

- Easements, restrictive covenants, pre-emption rights and boundary disputes;

- Commercial landlord and tenant law, including lease renewals under the Landlord and Tenant Act 1954, breaches of covenant, break clauses and forfeiture proceedings;

- The law of service charges and dilapidations;
- Trusts of land;
- Adverse possession;
- Nuisance and trespass proceedings;
- Leasehold enfranchisement; and
- Proprietary estoppel.

Before coming to the Bar, Thomas read German and Russian at Jesus College, Cambridge, where he was also a choral scholar. He continues to engage in musical life, including singing in his local parish choir and making regular visits to the opera.

Recent cases



- Re Rennie Court (LON/00BE/LSC/2022/0234 2 November 2023): Following a four-day hearing, Thomas successfully obtained a determination from the First-tier Tribunal that the vast majority of service charges claimed in respect of a prominent estate on the South Bank were payable. The case raised a wide range of legal issues, including contractual interpretation, the requirement for charges to be reasonably incurred, the application of consultation requirements and the validity of service charge demands.
- Watson v (1) Cole (2) Komoda (HHJ Parfitt, Central London County Court, 7 July 2023): Thomas successfully represented the Defendants at a five-day trial concerning a boundary/party wall dispute between neighbours in west London. The case was widely reported in the national media.
- Corpus Nostrum Limited v Buckinghamshire NHS Trust (Recorder Shepherd, Oxford County Court, 19 January 2023). Following a contested trial, Thomas successfully established the Defendant landlord's opposition to the grant of new tenancy, relying on grounds (f) and (g) in section 30(1) of the Landlord and Tenant Act 1954.
- Re Albion House (LON/00AU/LBC/2021/0084 19 May 2022): Thomas successfully represented the Applicant at a two-day hearing before the First-tier Tribunal relating to the excessive generation of noise and obtained a determination of breach under section 168 of the Commonhold and Leasehold Reform 2002.
- Savill v Elkesley Parish Council & Ors (Sheffield County Court, HHJ Sadiq, 11 March 2022): Thomas successfully established the existence of a prescriptive right of way on behalf of the Claimants following a contested 2-day trial.
- Ainscough v (1) Ainscough (2) Bank of Scotland Plc [2020] EWHC 2909 (Ch): This case related to the application of the law of abuse of process to decisions of HM Land Registry and also "exceptional circumstances" in which it is appropriate to refuse to rectify the title register. Thomas successfully represented the Second Defendant in a two-day High Court trial.
