

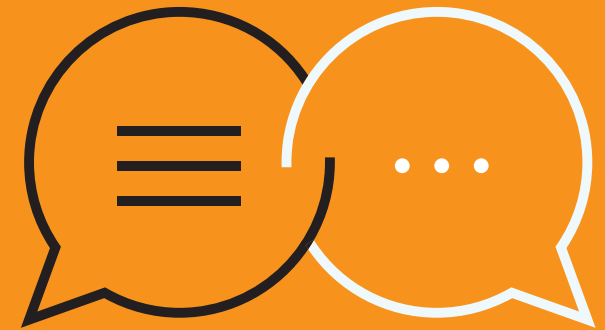

2019 Seminar Series

Contracts: the formal, informal, implied and naturally understood.

Two recent Supreme Court decisions have highlighted that notwithstanding the principles laid down in Marks and Spencer plc v BNP Paribas Securities Services Trust Company (Jersey) Ltd [2015] UKSC 72, deciphering the terms of an agreement is not quite as simple as it ought to be. With a focus on the practical implications for the practitioner, Tricia Hemans and Thomas Rothwell will consider the impact of the decisions in MWB Business Exchange Centres Ltd v Rock Advertising Ltd [2018] UKSC 24 and Wells v Devani [2019] UKSC 4. Both cases provide important insights into the Court's approach to informal agreements. This interactive seminar will help to shed light on the effect of "no oral variation" clauses and their ability to prevent informal variations of a contract as well as situations where a term may be neither express nor implied, but rather "naturally understood".

A Practitioner's Guide to Enforcing Covenants in Leases of Flats

@personsunknown: service in the digital age

There are an increasing number of cases of protesters, urban explorers and other trespassers occupying and disrupting valuable activity on non-residential land. These present challenges that require creative thinking from litigators: identifying groups of trespassers as parties, service of proceedings via social media, obtaining removal from the internet of videos that might incite future trespass, and overcoming human rights defences based on freedom of expression. This seminar draws on Chambers' recent experience with high profile cases involving fracking protesters, hunt saboteurs, and urban explorers and presents a practical guide to resolving these cases. It will also examine the implications of the recent Supreme Court Decisions in Cameron v Liverpool Victoria Insurance and UKI (Kingsway) v Westminster CC.
